REQUIREMENTS COMMON TO ALL MODALITIES

- Completed and signed order form;
- Attach 3 typographic reproductions of the sign measuring 7/7 cm;
- Present personal identification if you are a natural person and proof of activity if you are a legal entity;
- Letter from the applicant requesting registration and/or appointing their representative at the time
- Proof of payment of the fee;
- For applicants not domiciled in Angola, they must appoint a local representative and attach a power of attorney;
- For applicants domiciled in Angola, it is optional to appoint a local representative, however, if they do so, they must attach a power of attorney;

SPECIFIC REQUIREMENTS FOR EACH MODALITY

BRANDS

- Each order must correspond to a class of product or service;
- Orders with more (+) than five (5) products or services will incur an additional fee for each one.

ESTABLISHMENT NAME & INSIGNIA

• License for the activity you carry out;

MODEL & INDUSTRIAL DESIGN

- **Drawing or Photographs of the Object**: They must allow a perfect visualization of the object, representing the bottom, top, front, back and side perspective views (x2);
- **Descriptive Report**: Its purpose is to help the visualization and understanding of the figures and should be included when necessary (x2);
- **Claims**: It is optional, although the application for registration of an industrial design or model may include claims, it must be remembered that protection will apply to the object as illustrated in the figures or drawings.

INVENTION PATENT & UTILITY MODEL

- **Claims**: What is considered new by the inventor (x2);
- **Description**: Clear and complete understanding of the object of the invention, so that it can be carried out by a person normally competent in the field (x2);
- **Summary**: Essentially intended for technical information purposes (x3);
- **Designs**: When necessary to understand the invention and referring to the description or claims (x2);
- **Priority Claim Document:**Copy of the patent application or other type of protection that has been filed in another country and that concerns the invention (PCT applications are exempt from this requirement).

Procedural Processing of Requests

- 1. Entry of the request with the IAPI secretary;
- 2. Formal examination and issuance of the application entry certificate;
- 3. 1st publication of the request at BPI;
- 4. With the first publication of the request at BPI, a period of 60 days opens for the presentation of any complaints by third parties who feel wronged by the request made;
- 5. If there is a complaint, the normal processing of the request is suspended, for analysis and decision of the dispute, depending on the allegations raised by the parties;
- 6. If there is no complaint, the request is submitted to a substantive examination for granting or refusal under the terms of the Industrial Property Law and international conventions on intellectual and industrial property to which Angola is a party;
- 7. Publication of the decision at BPI.
